105 REPORTS FROM OTHER BODIES

Cllr Squirrell reported that the WSLA have received a grant from the Football Foundaton towards the cost of the maintenance of the pitch, bookings are good and, they are working to get broadband installed and that hirers have requested an up grade to the MUGA – Multi-Use Games Area

Cllr Houston reported that the Memorial Hall have closed the sub committee as the process to move to a Charitable Incorporated Organisation is complete. The second version of the plans are due in March 2025 and then they need to be signed off by the groups involved. The title of the Hall needs to be changed, there are currently 3 individuals including Kerri Wilcox the previous Clerk and advice from ACRE – Action with Communities in Rural England has been taken and Cllr Houston will provide more information to Council

Cllr Moore reported that there has been a change in all the Officers at the Wistaston Community Council and that there has been an increase in attendance and income at the events so far. They now have a social media team, an assistant treasurer, team leaders for each event and a card reader for use at events. The Community Council need more members in the 100 Club, and they are reviewing a higher interest account in addition to the existing current account for payments. There was a discussion about the lighting at the Firework event in November around the entrance/exit and if there was a way that this could be improved for the evening, the Clerk is to write to the WSLA about the lighting. The Community Council have made Kate Blakemore of Her- Place Charitable Trust (previously Motherwell, Cheshire) as Wistonian of the Year 2025.
